Summary of the methodology

The verification was conducted based on NDPE IRF Verification Protocol Version Nov 2020 (version 5.8) through remote verification. SDGI has compiled 14 IRF profiles with 141 mills for the reporting year January-December 2023. This include 45 are in delivering category, 29 in progressing, 33 in commitment and starting action, 4 in awareness and 30 in known category. For verification purpose, verifiers have selected samples as per the sampling methodology stated in the protocol and only the volumes sourced by SDGI's facilities in 2023 have been taken into account that includes Crude Palm Oil, Palm Kernel, Crude Palm Kernel Oil and Refined Palm products.

Conclusion

Control Union's responsibility was to exclusively verify the accurateness and completeness of the IRF methodology and processes for the calculation of the IRF profiles for the facilities in the scope of the assessment. Based on the information and evidence presented to Control Union, SD Guthrie International as the data aggregator has been verified and found compliant with the methodology detailed above.
