Facilities included in the scope of this evaluation:

SD Guthrie International has achieved **95.7% Traceability to Mill (TTM)** in 2023 based on percentage volume of all product (Crude Palm Oil (CPO), Crude Palm Kernel Oil (CPKO) and Palm Kernel (PK) and Refined Palm) supplied to each of its refinery, biodiesel and palm kernel crusher ("KCP") :

Verification methodology of Traceability to Mill:

- For the verification purpose, several mills have been selected for sampling based on several factors such as volumes supplied and number of deliveries.
- Reported traceability figures by SD Guthrie International for the facilities in the above table were reviewed by cross checking the information of the selected supplying mills and record of deliveries across the entire year. The traceability score is then cross checked using the following formula: (Total traceable volumes per refinery/Total purchased volumes per refinery) x 100.
- A mill is considered traceable when the following information are available: parent company name, mill name, RSPO certification status (optional), location and the longitude and latitude coordinates.
- Control Union's responsibility was to exclusively verify the accurateness and completeness of the information as received from SD Guthrie International and as per their methodology and processes for the calculation of the traceability scores for the facilities that are included in the scope.
